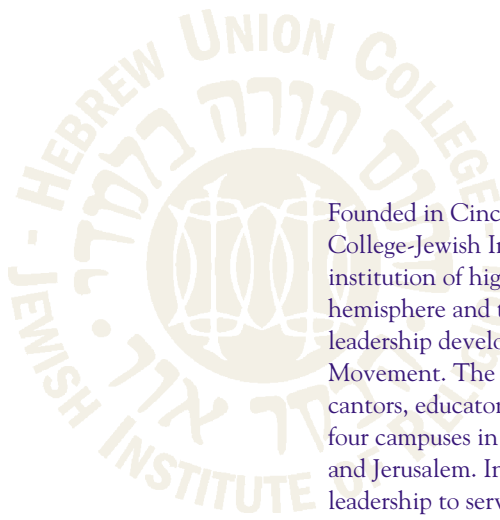




24th Annual
Cincinnati Associates Tribute Dinner



Founded in Cincinnati in 1875, Hebrew Union College-Jewish Institute of Religion is the oldest institution of higher Jewish education in the western hemisphere and the academic and professional leadership development center of the Reform Movement. The College-Institute prepares rabbis, cantors, educators, and Jewish communal workers at its four campuses in Cincinnati, New York, Los Angeles, and Jerusalem. In addition to training professional leadership to serve the Jewish community, HUC-JIR's School of Graduate Studies, located on the Cincinnati campus, awards masters' and doctoral degrees to men and women of all faiths.

The Cincinnati campus is situated adjacent to the University of Cincinnati. Included among the treasures of the campus are the Skirball Museum, housing Jewish ceremonial and ritual objects focusing on immigration, American Judaism, the Torah, Jewish life cycles and festivals, and the Holocaust; the HUC-UC Center for the Study of Ethics and Contemporary Moral Problems, a national resource center for the exploration of critical ethical and moral issues; The Archaeology Center, a permanent collection of archaeological artifacts in an interactive learning environment; the Klau Library, Cincinnati, one of the most significant Judaica and Hebraica libraries of the world; the Dalsheimer Rare Book Building housing illuminated manuscripts, Biblical codices, communal records, legal documents, scientific tracts, and the Eduard Birnbaum Collection of Musical Manuscripts; and The Jacob Rader Marcus Center of the American Jewish Archives, a major center of study, research, and publications preserving over ten million pages of documentation recording the history of Jews in the Western Hemisphere.

H. Jerome Lerner is the owner of HJL Enterprises, a management consulting services company located in Cincinnati, Ohio, that he founded in 1985. Jerry looks back on an impressive career in business, spanning more than 40 years from his first position as Director of Trade Development (1961–1963) at DuBois Chemical Inc. (now part of Johnson Diversity) to Chairman of Crane Connectors in Cincinnati. Before joining Crane Connectors in 1985 and retiring from it in 2004, Lerner also steered other companies, including Metropolitan Distribution, Inc. in New York, serving as its Chairman from 1986 to 1988. Most of his extraordinary career, however, was spent as Executive Vice President of Texo Corp. (1963–1985) and as President of the Straus Keilson Company (1971–1986).



Jerry has also been very involved in the local community, serving on many company boards; especially noteworthy are the Touchstone Family of Funds, Cincinnati, and BASCO Shower Enclosures in Mason, Ohio. In addition, Jerry has been a longstanding member of the Board of Governors of Hebrew Union College-Jewish Institute of Religion and served as co-chair of the Cincinnati Board of Overseers from 1997 to 2000. He has been active in other Cincinnati community organizations, holding positions on various boards including chairman of the board of Cedar Village, and the Jewish Federation of Cincinnati, where he served as campaign chair.

A native of Cincinnati, Jerry is a graduate of Walnut Hills High School. He earned a bachelor of science degree from the prestigious Wharton School—the world's first collegiate business school—at the University of Pennsylvania. He received a master's degree in Business Administration from the University of Cincinnati.

His wife, Mimi Kuby Lerner, and he have three children, Andrew, Karen, and Julie; and they are the proud grandparents of Natasha and Louis Nicholas Lerner and Kyle, Nina, Bryan, and Sadie Javello.
